- Update on the status of boundary clarification/sign Green Valley and CHCA (All). Discussion re Portia Clark's email and letter to Ron dated 6/18/20 re sign placement on 16th St S and WR and the apt building facing WR belonging to GV; we are not trying to claim the apt, but rather distinguish the demarcation between the two neighborhoods.
